The below principles are followed:

- Protection of workers' health through the tight integration between the identification, assessment and mitigation of specific risks related to the job, monitoring and improvement of environmental conditions in the workplace and health surveillance programs;
- Identify through proper and periodically updated risk analyses the possible health, safety and environment emergency scenarios, define the emergency plan in line with health, safety, environment and public safety best practices;
- Analysis, in their dynamics, of any accidents / injuries, near misses or emergency situations, with a view to continuous improvement of prevention and protection also through dissemination of *lesson learned*,
- Promotion of Employees consultation and participation to the risk and opportunity evaluation as part of the continuous improvement process;
- Periodic information to employees, trade unions, top management, O.d.V., regarding the objectives and results achieved;
- Collaboration, when required, with competent Authorities for the definition of standards and guidelines related to Health, Safety, Environment, Energy;
- Promotion of the Quality culture as way to be and to operate, as important influential tool and invaluable element for a sustainable development;
- Periodical review of the above principles and scheduled checks on their application.
